We only use your personal data for the following purposes:

- 2. Permanent Guarantee of the technical functionality, user-friendliness and further development of the Application (legal basis: consent, Art. 6(1) lit. a) and Art. 9(2) lit. a) of the GDPR).
- 3. Legally prescribed processing purposes, such as billing to a health insurance company or to fulfill of legal obligations related to medical products, etc., but also as defense of legal claims (legal basis: legal obligation, Art. 6(1) lit. c) of the GDPR in conjunction with the respective special statutory provision, Art. 6(1) lit. d) and e) of the GDPR and Art. 9(2) lit. c), f) to j) of the GDPR, insofar as applicable.

7. Description of the necessary data processing within the scope of the intended use

7.1 Processing of inventory data, payment data, etc.

7.2 Processing of special categories of personal data (biometric data, health data, demographic data etc.) We process your personal data for the following purposes:

- Treatment support: providing therapy resources, tools and exercises to help you improve your speech outcome
- Provision of speech therapy services: processing video data to extract relevant facial features to detect and interpret movements of facial muscles involved in execution of relevant speech therapy exercise
- Personalization: adapting the settings to the user's facial parameters to ensure accuracy of exercises' assessment; adapting the therapy to the user, including adaptation to age and disabilities
- Customization: creation of Individual Plan of Care (IPOC), relevant to the user's state, age and progress
- Progress tracking: generation, storage and display of user's performance to measure the effectiveness of therapy and amend IPOC if needed
- Research and development: Conducting analysis to improve the quality of our therapy programs, develop
 new features and contribute to scientific research in the area of speech therapy. If possible, such analysis
 is always based on anonymized and aggregated data, so that no information that directly identifies you is
 processed.
- 7.3 Processing your billing data, consisting of the activation code you entered, which is provided by your payment processor or health insurance company, to bill our services in connection with the use of the App and forwarding this to the responsible health insurance company for billing purposes if the service is from your health insurance is reimbursed.
- 7.4. In connection with the fulfillment of our statutory obligations to which we are subject, we process your data provided as part of the intended use of the App, including user, application, technical and billing data, such as in particular to fulfill obligations under medical product law, such as for Carrying out conformity assessment procedures and monitoring the App after it has been placed on the market.
- 7.5. In order to bill or fulfill our statutory obligations, we can also pass your data to the responsible payment processor or supervisory authorities, whereby we usually only pass on your data in pseudonymous form, so that no information that directly identifies you is communicated.

8. Withdrawal of consent and other rights

You have the right to access, rectify, restrict or object to the processing of your personal data. You can exercise these rights by contacting our Data Protection Officer at the provided contact information in Section 2.

You have the right to withdraw your consent at any time via settings menu in the EZSpeech Application. Please note that if your consent to the intended use of the application is withdrawn, all functions of EZSpeech Application will naturally no longer be available to you and your account will be deleted.

For children under the age of 18 consent or withdrawal of consent should be given by their parent or legal guardian.

9. Privacy by default

In accordance with the data protection principle "Privacy by Default", our application allows individual adjustment of certain features in certain cases. All features offered within this application are fundamental part of the intended use and are required for optimal use of the application as a whole. However, Mila4Al Inc. understands that different people may have different preferences in terms of communication, sustainability control, etc. so some features are designed to be optional and can be turned on and off via "settings" function in the Application.

11. Use of cookies

When you use the Application, we may utilize cookies for authorization purposes. Cookies are small text files that are placed on your device's browser when you interact with our application. These cookies serve as a means of securely identifying and authenticating you as a user.

12. Data retention

We will retain your personal data only for as long as it is necessary to fulfill the purpose for which it was collected, as it is outlined in this Data Protection Declaration. The specific retention periods may vary based on the type of data and the purposes for which it is being processed. Generally, we will retain your data for the following retention periods:
